Today I got a short discussion with a German politician about the unconditional income. And he told me that politicians understand that it is an income where people should not get child benefit, raising allowance or help if the handicapped or have disables bodies. The income should not higher than 400.00 Euro in a month. And they will no other help. Especially it will only valid for German, foreign will get more.

That is not that way which is usefully. We in German have a got a social law which is complicated as anyone can imagine. We have 12 books of social law. And they bespeaks each other's.

So if we do a ground income, we must do it so high that people can exists. I found 1,500.00 Euro for each German citizen.

German citizen are people which life in German and have a permission to stay endless in German or own a German passport. In the moment foreign people have a higher income than German. That is done by reforming the law for foreignness. But they forgot often to reform the income of Germans.

The credit law founded from each credit person an income higher than 2,000.00 Euro in a month before they can response a credit. So this is the mark where people have a

Fair payment is of course important, but companies must be able to pay. To give a concept in every detail means to make people uniform. And kill any kind of individuality. A concept like a ground income means to find a ground where you did start. So work is an individual system of self-esteem and self-honor. You can't aspect that everyone

think like you do or get the same inspiration of work.

If I start with an inspiration I would give for a single house hold 1,500.00 Euro, plus 400.00 – 500.00 Euro free income. If some got more, as an employer, cut 90% from the lying over income. Of course self-employer and others must get other rules.

Each child need in a month around 700.00 euro to stay. Of course childhood, school, education must be free. Universities must be free or give in a time of 30 years to pay university by education insurances. So as you can see it is a process it is not able to change an economy structure in a day, as specially that what is so destructive like the German.

If a par-ship stay together the income should stay by 2,500.00 Euro in a month, of course the plus could be less than 400.00 euro; so

as the minus of 95% from the lying over income.

So it is a start I do, but it is not finish. It is a respect of democracy; I make a dream of a better future and construct an idea. But the place for each individual human must come by discussion and place for existing and growing. In the last few days I discuss and to go through a hard time of control by the official government and people. That give me a new look on an economy which runs wrong, so as people which life's from to oppress other people. I read also article which wrote, that this generation is a lost generation by behavior and income. I agree, but it is time to take a look to the future! How we can change all this which makes people invalidly.

I start by law, we have different kind of law that is right. But how can one law be against another law? So we have to look differently. We have on right for social – help, on right for “companies” one for tax. Like to go through an example:

I got privately value stuffs by living, I used it for years to fixe credits for my company. One time I lost my home because the wife I married dropped my out of my house. (The law allow that in Germany). So I was homeless for 9 month, any think went right and I got a new home. She was selling my stuffs and the company I rent a warehouse used it to sell my stuffs also. So at the end I lost my house and my warehouse.

In Germany the house will fixe in justice with the half price of declared in front of a civil law notary. So the value of a house is normally

less than a quarter of the real price.



The company which took my stuffs, ground a charity foundation for the child's. The law in Germany allows that and fixe that the foundation is not in succession in title until the day of grounded. So I have no possibilities to get the stuff back or my money, that to declare tock's more than 7 years. During this time I not activate my private materials for company. Until someone in the financial office ask for a credit which was founded 10 years ago. The Ltd – law write down, that I have to reactive the private material in the company. So I do that, but the financial – law write down that

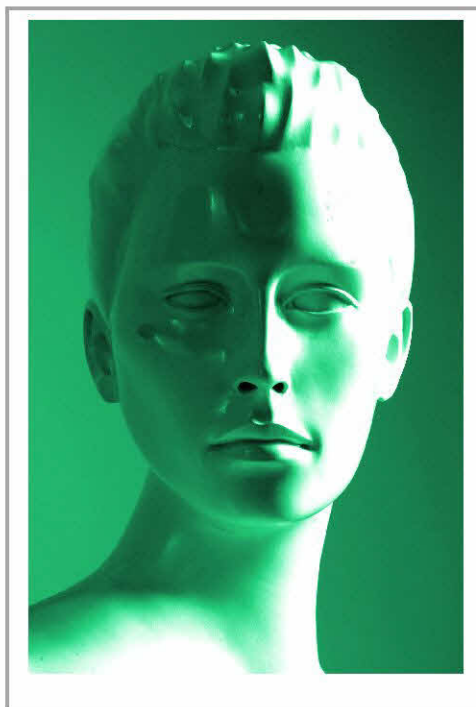
is not possible. That comes that I got a control for two days of my financial books. The end is that the financial office told me, that I must pay for every volume, equal if the persons pay or not, tax. That means I got one Euro and have to pay 19% tax equal if I have one Euro costs or if the person not pay. That means every breath I took in work, I pay.

On the other side, the social – law wrote done, that they believing I have values and if the office worker have the believing of believing that I can spend money, they allow to stop the social help. Any case in that I have no money or give them documents to prove that I have not enough income they have not to accept this documents or the reality.

That is the way government get a high income for the state. Equal if resident have an income or not, it is not the

question if they work or not; they must pay.

By that way the German government pay for each person which needs ground social – help 100,000.00 € a year. To solve 12,000.00 € maximum. In my case it is only 6,400.00 €.



So it will not a question if it is possible to pay ground – income or not. If they stop this way and pay each after checking the accounts for positive dispose (without Life insurances or pensionfonds), they can pay.

So they can commuted the tax. Donald Trump do that for companies and the result is in one year that USA get billions of Dollars more tax than before.

So there is no argument against it only to make thinks complicate than it will be useful or helpful.
